

At the Good Samaritan Society in Water Valley, philanthropy helps residents like 89-year-old Lou Warner not only maintain her independence, but also enjoy a fulfilling lifestyle thanks to enriching activities, healing spaces and special programs designed to brighten the spirits and enhance the well-being of our residents and families.

"I think it's a great place to live. I have so many friends

here and so many that have given me so much support when my husband passed away. It's really wonderful that I can be here," Lou said.

NEBRASKA

At the Hastings Village Good Samaritan Society in Hastings, your support is helping to enhance the well-being of residents like 81-year-old Bev Frerichs, who enjoys dinners with friends, activities like shuffleboard, and opportunities to volunteer for the Society's bargain center, library and community center advisory board.

For Bev, Hastings Village has been a lifeline following the death of her husband, Ray, two years ago. Downsizing from an acreage to a support system at the Society got her through.

"It's kept me going. I get out probably every day. There's always something going on here at this campus," Bev said. "The staff are very, very nice. They know you. They know you and they hug you."





SOUTH DAKOTA

At the Good Samaritan Society in Sioux Falls, philanthropy helps ensure that dedicated staff and volunteers are on hand to provide around-the-clock care and compassion for our residents and patients who need long-term and hospice care.

For Jackie Payne, whose grandmother Ardis Dexter entered hospice care late last year, hospice offered the gift of time. Time for reminiscing together. Time

"No one has been more influential or had a greater impact on my life than my dear Grandma Ardis. Losing her was heartbreaking, but I'm so grateful for the compassionate care she received during her final days, as well as the support our family received from staff as we shared our last treasured moments and memories together," Jackie said.

The spirit of philanthropy and the power of collaboration shine brightly at the Good Samaritan Society in Arthur where, thanks to your generosity, dedicated staff often step forward to accept and care for patients from the Sanford Medical Center in Fargo during times of high census. 
